3. We Undertake to provide the requisite building facilities for housing the School / Class / Rooms /Liabrary/ Laboratory as prescribed By Government.
4. We Shall not appoint any teacher whose certificate has suspended or cancelled an who hsa been declared unfit to be a teacher in recognized schools or who has been contined for Officers involving moral attitude.
5. We undertake that in addition to the caution of the endowment the educational agency shall also deposit in the Indian Bank or in any Banking company to which the Banking Regulation Act 1949 (Central Act 1949) applies in the name of the Staff employed in the School to serve as a working of the School.
6. We Undertake not to collect capitation fees /donation from the students of their parents who seek admission in the School.
7. We Shall collect tuition fees and other fees from the stundents at the rates as prescribed by Government.
8. We Shall confirm to the rules and regulation of Government and the Director of School Education issued from time to time.
9. We Undertake that the educational agency shall fulfill all the conditions stipulated by the competent authority at the time to according permission to open the school or for Starting additional standard or section.
10. We agree to function under the control of the Director of School Education. The School may be inspected at any time by the Director of school entailed for future of the permission granted to start the school and the Government shall have the right to taxes over the school of Question at anytime with all its movable immovable properties including cash balance tec, with paying any compensation.
11. We shall not ask for the grant or aid from the Government forever.
12. The Condition agreed to above are irrevocable.
